Showing off your Family Tree at January 6 Meeting

Now you have created a large or small family tree and you are thinking about displaying all of your hard work. Learn about your different choices at our January meeting. Pat Skubis has assembled a slide show, with basic family trees to high-end trees that can include photos, names and other facts. Even Martha Stewart has projects that can be automatically entered onto the painted or displayed on your walls. Patterns for these trees can be downloaded for free and either print them yourself or come with step-by-step directions.

Like to embroider? Many patterns are available. Or if you are interested in scrapbooking you can create books with photos, writings or documents using various background papers. Also check your software program, you may be able to create a nice family tree with a lot of the information to be displayed on the tree background. You can also put in photos of family members and have a larger poster made for about \$30.

Not into doing it yourself? Then you can take advantage of having one made for you. Depending on what you want to include the prices can become fairly steep.

For those of you who already have a completed family tree, you are invited to bring it and share it with other members at the January meeting.

Wisconsin Veterans Museum Research Center

The Wisconsin Veterans Museum Research Center is well positioned to join next year in recognizing the 150th anniversary of the Civil War we learned from Russ Horton at our December meeting. He is Museum's Reference and Outreach Archivist.

An impressive collection of official records and memorabilia, available at the Museum and online, documents the stories of 91,000 Wisconsinites who served in that conflict.

Horton, who also addressed us in August 2008, reviewed the history of the Museum and brought us up to date on documents and research opportunities which have become available since then. A

polling of the audience before he started revealed that to most, it was all new material. For others it was a review of the abundance of records available to us of five conflicts, from the Civil War and through WW I.

A newer acquisition is Civil War Muster Rolls which can be reviewed at the Museum on microfilm. Arranged by unit, the rolls often provide personal information such as age, birthplace, occupation, physical description and remarks about service. Also for Civil War researchers are draft records, veteran census reports, and a roster of Wisconsin volunteers. There are even rosters from several neighbor states as well as Vermont and Massachusetts.

This is in addition to 18,000 book titles and 2,300 periodicals dealing with the Civil War.

To questions about actual service in the Civil War. Russ said initial enlistments were for three months. Desertions were not uncommon but often represented only a temporary absence to handle duties at the home farm. Draftees were permitted to "buy" a substitute to avoid active service.

New among World War I resources are Bonus Cards/Service Records. Compiled following the war, these often provide birthplace, age, residence, dates of enlistment and muster out, decorations, campaigns, dates,

of enlistment and muster out, decorations, campaigns, dates served overseas, wounded status and physical description. They are screened from microfiche. WW I roster books are searchable by name, city or country. The database provides rank, serial number and unit.

Regarding the Mexican Border War, the Museum hopes eventually to have a searchable index but presently, one would have to know a unit description to find a family member who served in that conflict.

Wisconsin was represented in the Philippine–American War, also known as the Philippine War of Independence or the Philippine Insurrection (1899–1902) but any who served were in federal units.

In the Mexican Border War, Wisconsinites served in infantry and artillery units and a field hospital. Muster rolls at WVM are arranged by unit and contain birthplace, physical description, occupation, marital status, residence and emergency contact. A published account of this war, With the Wisconsin National Guard on the Mexican Border in 1916-17 by Moses N. Thisted includes printed rosters of Wisconsin units and other valuable research tools.

A Wisconsin statute restricts access to information of those in post-WW I conflicts to close relatives. At the national level, the same type of information is considered confidential and available only to the subject or his/her next-of-kin.

A practical suggestion from Horton: If we would like to see Wis. Stat. § 45.04 amended to be less restrictive and thus provide better access to these records, approach state representative(s) who might be persuaded to sponsor a bill incorporating the necessary changes.

Will the vast store of Civil War data at WVM ever be fully digitized and searchable? Horton sees this as an attainable goal, given time, funds and a cadre of volunteers. To the For both Civil War and WW I soldiers, the Museum can generate a handsome Certificate of Service for \$10 on site. It includes personal data and complete service record.



later, he encourages anyone who would like to have a role in the work of the Veterans Museum to be in touch with him. Another approach could be a contribution through the Wisconsin Veterans Museum Foundation:

Donated correspondence collections get close attention at the Museum, according to Horton. They usually represent letters exchanged with a spouse or with other family members. Warrelated stories are carefully checked and then catalogued under appropriate headings. Such collections will always be available for descendants to consult, he added.

Present location of WVM at 30 W. Mifflin St. downtown is comparatively recent, but it is proud of its growth which includes the state of the art Research Center, and accreditation by the American Association of Museums, Horton noted.

Questioned about resources relating to many conflicts, Russ displayed a comprehensive



knowledge of Wisconsin military matters up to and including WW II. And he was generous in offering assistance to those presently engaged in genealogy involving Wisconsin's service forces. Russ suggested a phone call or e-mail to him which could bring a direct answer or suggestion of how to proceed.

Where: The NGS 2011 Family History Conference will be held at the North Charleston Convention Center in Charleston, South Carolina.


When: Mark your calendars for 11-14 May 2011.
