An Old Settler Gone,

Anders Pederson died at his home in Central Park at 11:30 a. m. today, aged fifty years. Funeral Monday at residence at 1:30. Remains will be taken o Duluth. Mr. Pederson was one of the old settlers of the West End. After the town plat had been filed Gen. Hammond made a public offer of ten lots to the first ten persons who should buy a lot and erect a building. thereon. The first to accept this offer was Pederson, who still has a greasy brown paper, described as "Contract No. 1." It covers lots 10 and 11, otherwise known as the southwest corner of Third street and Tower avenue. He paid \$500 for the corner lot but upon crecting the required building received a rebate of \$175 and the other lot free. The deceased leaves a wife and two children, C. C. Pederson and a daughter. His estate includes considerable property at Central Park. Among his possessions are about fifty dwelling houses in different parts of the city.

George will show you how to find funeral homes and newspapers serving your family, search for obits mentioning them, cut and paste those obits in your software, create a source note, and extract more information from the obituary than you ever thought was there.



George Findlen, CGSM, is a retired academic administrator who has served as a faculty member or administrator at nine colleges and universities in seven states over thirty years.

In retirement, he has re-invented himself as a genealogist, becoming certified in 2005 and recertified in 2009. He researches Acadian and French-Canadian families in Eastern Québec, the Canadian Maritimes, and New England. In addition to researching his family, he writes articles for publication. His articles have appeared in the National Genealogical Society Quarterly and several New England and Québec genealogical society journals. His most recent effort describes the results of a DNA study which documents that the two Acadian Martin immigrants are not related.

The article he is proudest of is "The 1917 Code of Canon Law: A Resource for Understanding Catholic Church Registers," published in the June 2005 issue of the National Genealogical Society Quarterly. The article is the first ever in any language to explain how Roman Catholic canon law can explain unique parish register entries.

He is currently writing a history of his Acadian lineage, a venture covering eight generations and 300 years of history.

He also likes to give talks to genealogists, and has addressed groups in three Upper Midwest states as well as at the New England Regional Genealogical Conference. He also leads groups through skill development exercises for the Wisconsin Historical Society Library and Archives. On Tuesdays, he volunteers at the Wisconsin Historical Society Library

"Breaking Through Brick Walls in the 21st Century" by Jim Hansen

Jim reminded us that there are still resources that are not available online. He did however tell us that there is no reason not to be able to find our ancestors on the census if they were part of it. They are all online and indexed! When you're searching probate records look for individuals without descendants they will often lead to siblings that will help you connect family lines. The most common issue when looking for probate records is that many people look for the will. Many of our ancestors did not have a will. Probate records can be filed multiple locations when assets are located in multiple locations or ancestors have relocated but left ties (assets, etc.) at their former home. In cases where the debts exceeded the assets there won't be recipients listed other than the creditors paid. Probate records can be filed multiple locations when assets are located in multiple locations or ancestors have relocated but left ties (assets, etc.) at their former home. Probate records may not be filed until the wife dies but the record may still be filed under the husband's name. Court cases can be used in conjunction with probate records to tie facts together. The website http://www.glorecords.blm.gov/ can be used to search for land records, specifically when land was transferred from the government to individuals. If you find "W" indicator it stands for Warranty land which means there is a bounty land application in the national archives. The bounty land applications are like mini-pension file. They are indexed only by the name of the soldier. They sometimes hold information by individuals related to the soldier. Revolutionary war pension files are now fully searchable and indexed. There are

available on Fold3 which the State
Historical Library has a subscription to.
Fold3 also has Civil War pension files
organized by Unit. There is a new book by
Christine Rose called Military Bounty
Lands 1776-1855. It explains everything
you would want know about bounty
lands.

A clue for finding divorce papers is to look for plaintiffs and defendants to have the same name. In suits with multiple participants sometimes only the first name is indexed. These records have survived when other have not. Look for blended families and broken families when researching – surname changes was not that uncommon.

There are a lot of answers out there. But the question you should ask yourself is, do I care enough to spend the energy on a maybe? Many renowned genealogists have lines that they decide they can't break the wall down, sometimes simply because they amount of energy it would take.

Local tax records can be extremely important in areas where precious other records exist; Kentucky and Virginia are an area that they are often used in. Draft lists on Ancestory.com indicate those who were ELIGIBLE, not necessarily those that served.

Many of these records are still in possession of the issuing government agency. There are times that state archives/buildings may have copies. You can sometimes gain access to these physical records if you know what you are looking for. One member relayed an experience at Dane County looking for circuit records. The physical records are stored at the historical society; however, the index is located at the court house.

It is not uncommon when minors are involved for guardians to be appointed. Guardianship documents are great resources.



Bylaws Changes

The DCAGS Governing Board proposes the following changes to the society's bylaws:

Article III (Membership) / Section 4 (Records)

Current wording: "The <u>Treasurer</u> shall maintain a permanent membership file, containing the names of all members of record since the organization of this Society showing the type of membership held."

Proposed substitute wording: "The Membership Committee shall maintain a permanent membership file."

Reason for this change: The current bylaws wording evolved from a time when the treasurer was also effectively the membership chair. DCAGS has a Membership Committee; the Governing Board believes it is appropriate to move nearly all membership-related duties to the care of the Membership Committee.

Article VII (Committees) / Section I (Standing Committees) / subsection a7

Current wording: "The Webmaster committee shall consist of one or more appointed members. It shall have the responsibility of maintaining the Society's web page and linked sites"

Proposed substitute wording: "The Website Committee shall consist of one or more appointed members. It shall have the responsibility of maintaining the Society's website and linked pages."

Reason for this change: It will make the wording more in keeping with current usage, and emphasize that the committee is charged with oversight of the website, not the webmaster per se.

These changes will be voted on by the membership present at the 5 April DCAGS membership meeting.

Note: The Governing Board decided at its February meeting that the language proposed for Article III in the previous newsletter was too restrictive and now makes the new proposal shown above.#

Sharing What We Know

I have been reminded lately of one of the best benefits of participating in a local genealogical society--sharing locality expertise. I wrote in last month's president's letter that I had attended a week long course in Swedish genealogical research in January. The course was held in Salt Lake City, which meant that I got to also spend some time doing research in the Family History Library--not nearly as much time as I would have liked, of course, but I was able to search for more data on the families of two of my great-grandparents. After the next DCAGS meeting, I have had the

opportunity to talk several times with another DCAGS member who is also very interested in Swedish research, and we have been sharing our specialized genealogical knowledge since then (so far she has contributed far more to this exchange that I have--hopefully that will change in the future). Not only has she shared her knowledge, but she has done lookups for me in several specialized resources with which she is familiar

One reason I am mentioning this is my belief that such sharing (that is, the linking of members with similar specific interests) should become easier in the near future. "We" haven't talked a lot about it in public so far, but the Board of Directors is working on a new

DCAGS website which should make members interests a lot more accessible to other members than has been the case with our occasional printed membership directories. So I want to encourage each member to include their interests in their member profile. Ideally I would have talked about this back in November, when you were filling out your membership form for 2012. But no matter for most members, as you will be able to update your profile quickly and easily from your own computer or a computer in your public library. I'm really eager to see how well this part of the new website works. Stay tuned!




